~~~~ **TOURNAMENT INFORMATION** ~~~~

1. State Final Tournament will begin wrestling at 8:00 AM sharp. Make sure that you allow ample time to enter buildings. Be ready to compete at 8:00 AM. Due to anticipated complete weight classes, wrestlers who are called three times will be marked as forfeiting their match.
2. Headgear is mandatory. Wrestlers **WILL NOT BE PERMITTED** to participate without the use of headgear.
3. No weight allowance or change of weight class is permitted for the state tournament. The state tournament is a double-elimination event. The top eight wrestlers will receive medals. Satellite weigh-in sites will be available prior to each State Tournament weekend.
4. Name of Club/Team/Town (use ONE only) listed on entry form for qualifier is what will be used for State Tournament separation. Club/Team/Town will be separated in the first round of State competition IF POSSIBLE.

## ***DIRECTIONS TO ALL TOURNAMENT SITES***

**Highland Regional HS:** From I-295 South Route 42S, Blackwood-Clementon exit, right turn bottom of ramp, right at traffic light, Highland HS on left. From Shore, AC Expressway to Route 42N. Coles Road exit left top of ramp. Coles Road to Peters Lane (3<sup>rd</sup> street on right), right on Peters Lane to STOP sign, Highland HS across the street. From South, I-295 North, follow signs for I-295, 76 local (center lane) to signs for Routes 76-676-130. Walt Whitman Bridge/Camden/Ben Franklin Bridge, Exit 1C (Mt. Ephraim-Gloucester). Left turn at STOP sign top of ramp, right on 295-42, Route 42 to Blackwood-Clementon Road exit right at bottom of ramp, right at traffic light, Highland HS is on left. **Tournament Director: Mike Grisko (856-784-2429)**

**Lakeland Regional HS:** From I-287 North or South, take exit 55. Follow signs for Wanaque, Route 511 North, travel north on Route 511 for three and three-tenths miles, make a right onto Conklintown Road. Lakeland HS is on right. **Tournament Director: Kurt Schmitz (973-839-9776)**

**Lakewood HS:** From the Garden State Parkway, take the Route 70 exit (Exit 88) towards Lakehurst / Lakewood / Brick Township. Make a right onto Route 9 North. Make a right turn onto East 7<sup>th</sup> Street. School is approximately one mile on left. **Tournament Director: Miles Hahn (732-370-1318 or 732-370-0997)**

**Lodi HS:** Located between Route 46 West and Outwater Lane. From Garden State Parkway South, Exit 157 to Rt. 46E. Go four traffic lights, ¼ mile past the fourth light take Rochelle Park exit. U-turn back onto Rt. 46. Exit at Lodi Plaza (Hamilton Avenue). First left is back of Lodi HS. From Garden State Parkway North, Exit 157, U-turn at first exit (River Drive) back onto Rt. 46 and follow above directions. **STREET PARKING IS VERY LIMITED – PLEASE ALLOW AMPLE TIME FOR ARRIVAL. Tournament Director: Anna Belli (973-365-4005 until 4:00 PM)**

**Northern Burlington Middle School:** From I-295 get off at Exit 52 (Columbus). Go three traffic lights, make left at blinking traffic light, proceed onto Route 206 North for two miles, make a right onto Mansfield Road East. Middle School is on the left. From NJ Turnpike: get off at Exit 7, get onto Route 206 South for two miles and make a left onto Mansfield Road East. Northern Burlington Middle School is on the left (next to HS). **Tournament Director: Ron VanSciver (609-298-2642)**

**North Hunterdon HS:** Near Clinton, NJ. Located one mile south of Route 78 (Exit 17) on Rt. 31. Turn right onto Regional Road to first driveway on the right. **Tournament Director: George Cole (908-268-6431) NO CALLS AFTER 8:00 PM**

**Randolph HS:** From I-287 to Route 10 West to Millbrook Avenue Exit (just before eighth light). Take jughandle and turn LEFT onto Millbrook Avenue. Follow for approximately one and one-half miles to Randolph HS on right. **Tournament Director: Teri Webb (973-9273709 – Voicemail)**

**Toms River East HS:** Garden State Parkway North/South to Exit 82, Route 37 East. Go seven traffic lights to Coolidge Avenue jughandle. Cross over Route 37, continue on Coolidge Avenue north for approximately one mile to Raider Way. Turn left, Toms Rive HS is on the left. **Tournament Director: Mike Barrone (732-278-8838)**

**Union HS:** From Garden State Parkway South go to Exit 141, right onto Vauxhall Road. Go five traffic lights, make a left onto Stahuber Drive, left at Union HS. From Garden State Parkway North go to Exit 139B, follow ramp, right turn back under Parkway, stay on street, bear right under bridge, Stuyvestant Avenue. Go to center island with cannon on it, make a left around cannon onto Elmwood Avenue. Second traffic light, left onto Morris Avenue. Go past first traffic light, right at Administration Building (Cooke Drive). Football field and school is on left. **Tournament Director: Rose Jacangelo (908-686-8063) NO CALLS AFTER 9:00 PM**
