1. STATE FINAL TOURNAMENT WILL BEGIN WRESTLING AT 8:00 AM SHARP. MAKE SURE YOU ALLOW AMPLE TIME TO ENTER BUILDINGS. BE READY TO COMPETE AT 8:00 AM. Due to anticipated complete weight classes, wrestlers who are called three times will be marked as forfeiting match.
2. HEADGEAR, ONE-PIECE COMPETITIVE SINGLETs, AND MOUTHPIECES (FOR WRESTLERS WITH BRACES) ARE MANDATORY. Wrestlers will NOT BE PERMITTED to participate without the use of these items.
3. NO WEIGHT ALLOWANCE OR CHANGE OF WEIGHT CLASS for the state tournament. The state tournament is a double-elimination even. The top 8 wrestlers will receive medals. Satellite weigh-in sites listed above will ONLY be available Friday PM prior to each State Tournament weekend.
4. Name of CLUB/TEAM/TOWN (Use only one) listed on entry form for qualifier is what will be used for State Tournament separation. Club/Team/Town will be separated in first round of State competition, IF POSSIBLE.
5. ALL SEEDING QUESTIONS/CHANGES MUST BE REFERRED TO THE HEAD TABLE PRIOR TO 8:00 AM ON THE DAY OF THE STATE CHAMPIONSHIP. ABSOLUTELY NO CHANGES WILL BE CONSIDERED AFTER THE 8:00 AM DEADLINE.

**ELIZABETH HIGH SCHOOL** *Directions:* Dunn Sports Center, 600 Pearl Street, Elizabeth, NJ

*Turnpike:* Exit 13. Follow signs for Routes 1 & 9 North/439/Elizabeth. Go through the light at the end of the ramp onto Bayway Avenue (439 North). Make a right at the 3<sup>rd</sup> light onto S. Broad Street. Continue on S. Broad Street. After crossing over Rt. 1 & 9, make a right at the 3<sup>rd</sup> light onto Pearl Street (Landmark: St. Elizabeth Hospital). Dunn Sports Center is just after Dwyer House.

*Parkway North:* Exit 137. At the end of the ramp, make a left (at the light) onto Westfield Avenue (Rt. 28 East).

Continue on Westfield Avenue until it ends at Broad Street. Make a right onto Broad Street. Go under the arches (train tracks). At the 6<sup>th</sup> light, make a left onto Pearl Street (Landmark: St. Elizabeth Hospital). Dunn Sports Center is just after Dwyer House.

*Parkway South:* Exit 140A to 82 East (Morris Avenue). Take Morris Avenue until it ends at the Broad Street arches (railroad overpass).
